



## Evangelical Lutheran Church in America

God's work. Our hands.

The Church Council of the Evangelical Lutheran Church in America (ELCA) met at the Lutheran Center, Chicago, Illinois, November 12-15, 2015. The council centered its work around daily worship, frequent prayer and personal reflections on faith. It lived into its commitment to be a “Book of Faith” council by participating in a Bible study led by the Rev. Kwame Pitts, pastor at Redeemer Lutheran in South Holland, Illinois.

### **Among the items on which the Church Council took action were the following:**

- adopted the document titled “Gender-Based Violence” as a social message of the ELCA and its accompanying foundational document
- recommended action to the Churchwide Assembly which would unify the three existing official rosters of laypersons (Associates in Ministry, Deaconesses of the ELCA and Diaconal Ministers) into a roster of Ministry of Word and Service
- recommended action to the Churchwide Assembly to amend the Constitutions, Bylaws, and Continuing Resolutions of the ELCA
- adopted a continuing resolution to address the election process of the Vice President
- affirmed Bishop Eaton’s Future Directions and Priorities of the ELCA process design and authorized the appointment of a Future Directions Table
- accepted the 32 Statements of Agreement from *Declaration on the Way* and forwarded them to the Churchwide Assembly for reception
- received the report and referred the recommendations of the Ministry to and with Same-Gender Couples and Their Families Working Group to the appropriate churchwide organization units for implementation
- affirmed the extensive efforts by the Presiding Bishop to call the entire church to confront racism and to include those efforts in a broader, comprehensive strategy towards becoming a racially and ethnically diverse church
- received the Theological Education Advisory Council (TEAC) report, created a comment period to provide feedback on this report, and appointed a working group to craft implementing strategies
- adopted the revised Candidacy Manual
- approved amendments to documents and a succession plan related to Corporate Social Responsibility
- approved a resolution regarding investment in specific Palestinian economic endeavors
- received the report in response to the 2013 Churchwide Assembly action related to reviewing the ELCA’s guiding documents on communion practices
- approved a revised 2016 fiscal year fund spending authorization of \$66,514,340 and a revised 2016 fiscal year World Hunger spending authorization of \$21,000,000
- approved resolutions regarding authority to act in financial matters
- appointed members to the Memorials and Reference and Counsel Committees for the 2016 Churchwide Assembly

- elected members to the ELCA Church Council Executive Committee; the ELCA Audit Committee, the Committee on Appeals; the board of directors of Lutheran Theological Southern Seminary, Lutheran Theological Seminary at Gettysburg, Lutheran Theological Seminary at Philadelphia, and Luther Seminary; and approved the designation of members to the board of directors of The Evangelical Lutheran Good Samaritan Society
