I.F Report of the Executive Committee

New members of the Board Development Committee for the 2019–2022 triennium were approved by the Executive Committee [CC19.10.33]. Appointments for the Audit Committee will come through the Budget and Finance Committee.

CC ACTION

Recommended:

To ratify the appointments to the Church Council standing committees for the 2019-2022 triennium.

I.F.2 Process to Elect Members to Executive Committee

At the first meeting after the Churchwide Assembly, the Church Council elects a new Executive Committee. In addition to the four officers of this church and the chair of the Conference of Bishops, seven members of the Church Council will serve on this committee for the 2019-2022 triennium.

To facilitate its work between regular meetings by ensuring input and perspective from each of its four standing committees, the chairs of those committees are elected to the Executive Committee. This occurred at the April 2019 Church Council meeting [CC19.04.20g].

The remaining three members of the Executive Committee will be selected through the following process.

- a. The first ballot shall be a nominating ballot for each of the following identified categories:
 - 1). Lay Woman, Person of Color/Speaks First Language Other Than English (one position). Vote for only one eligible nominee.
 - 2). Lay Man (one position). Vote for only one eligible nominee.
 - 3). Rostered Man (one position). Vote for only one eligible nominee.
- b. Anyone wishing to withdraw may do so immediately after the announcement of the first ballot results and before the casting of the second ballot.
- c. Three-fourths of the votes cast on the second ballot shall be necessary for election.
- d. The third ballot shall be limited to the two people (plus ties) receiving the greatest number of nominations. The one candidate receiving the highest number of votes shall be elected.
- e. Upon completion of the balloting, the Executive Committee shall be deemed constituted.

CC ACTION

Recommended:

To affirm the process for the election of the Executive Committee for the 2019-2022 triennium.

I.F.3 Synod visits by Church Council Members

To note that expenses for attending Synod Council meetings and Synod Assemblies will be reimbursed by the churchwide organization in accordance with the ELCA travel policy.

III.E.1 Update on Mission Support Experiments

At its April 2015 meeting, the Church Council affirmed "a three-year experiment beginning in 2016 and involving five synods (New England, Nebraska, Metropolitan Washington, D.C., Lower Susquehanna, and Texas-Louisiana Gulf Coast synods) to form a "learning community" to explore whether retaining the new and renewing ELCA grants for ministries and the total compensation for the director for evangelical mission will produce an increase in mission support and more effective management and oversight for the sake of mission..." [CC15.04.15].

The experiment timeline was extended to January 31, 2021, at the November 2018 Church Council meeting [CC18.11.22]. A group of bishops and churchwide staff were asked to bring a progress report to the April 2019 Church Council meeting. At its April 2019 meeting, Church Council accepted a multi-step process "to measure and communicate the results of the Mission Support Experiment" [CC19.04.13]. One of the steps is "to provide updates at each Church Council and Conference of Bishops meeting between April 2019 and November 2021." An update on the experiments will be provided at this meeting.

IV.B Report of the Program and Services Committee

The following report is provided by the Program and Services Committee. Additional items or revised actions may be distributed following the committee's meeting. *En Bloc* items will be acted upon later in the meeting. IV.B.1 Update on Vision and Expectations/Trustworthy Servants

Vision and Expectations is a document developed to express the ELCA's vision for ordained ministry and the expectations this church places on ordained ministers. It was adopted by the Church Council at its October 1990 meeting [CC90.10.84]. The last revision to *Vision and Expectations* was at the Church Council's April 2010 meeting [CC10.04.09 and CC10.04.10] following the actions of the 2009 Churchwide Assembly.

This church's governing documents (*Constitution, Bylaws, and Continuing Resolutions of the Evangelical Lutheran Church in America* bylaws 7.31.01., 7.61.01, and 14.21.02.) assign the adoption of *Vision and Expectations* to the Church Council.

Vision and Expectations underwent another review and revision following the 2016 Churchwide Assembly when the unification of the three lay rosters was approved. After extensive revision, a draft was presented to the Conference of Bishops at its fall 2018 meeting. Recognizing the hurt and pain caused by Vision and Expectations to the LGBTQIA community, the Conference of Bishops recommended a new and differently named document be developed and presented to the spring 2019 meeting of the Conference of Bishops.

In collaboration with the Leadership Committee of the Conference of Bishops, a writing team was identified, and work began to rewrite the new document, "Trustworthy Servants of the People of God." At its spring 2019 meeting, the Conference of Bishops reviewed and offered advice and counsel, in accordance with the Constitution, Bylaws and Continuing Resolutions of the ELCA. The Conference of Bishops advised the Domestic Mission unit to present the new document to the Church Council at its April 2019 meeting with the understanding that Trustworthy Servants of the People of God is aspirational, and the ELCA Constitution and the Definitions and Guidelines for Discipline are the documents that focus on discipline. A public comment period was provided following the spring 2019 Conference of Bishops meeting.

At its April 2019 meeting, the Church Council reviewed the comments submitted during the public comment period and the feedback shared during the meeting; the Program and Services Committee presented a recommendation. The Church Council action was to decline to consider *Trustworthy Servants* and referred the document to Domestic Mission unit for further review and drafting that is governed by this church's social teaching documents [CC19.04.11].

Social statements are the teaching documents for this church, setting the standards by which all other documents are developed. The process for creating social statements is extensive, involving thousands of voices across the ELCA.

Based on the Church Council action, the Domestic Mission unit began an intentional process that includes periodic communication to rostered ministers, a <u>web page</u> for information about the process, and a listening group with diverse voices. Church Council requested the Domestic Mission unit

V.A.1 Memorandum of Mutual Recognition

The "Memorandum of Mutual Recognition of Relations of Full Communion Between the Churches of *Called to Common Mission* (The Episcopal Church and the ELCA) and the Churches of *Called to Full Communion: The Waterloo Declaration* (The Anglican Church of Canada and the Evangelical Lutheran Church in Canada)" proposes to reach across a national border to strengthen ties between the two U.S. churches and the two in Canada. Already each church is in communion with two of the other three: with its full communion partner in its own country—for the ELCA, this is The Episcopal Church (TEC)—and with the church of its own tradition in the other country—for the ELCA, this is the ELCIC. Already the four churches recognize bonds among them: for example, the four presiding/national bishops meet annually and collaborate in seasonal devotions. Yet each church lacks a formal relationship with one of the four; for the ELCA, this is with the Anglican Church of Canada (ACC). This Memorandum relies on the theological and ecclesiological agreements already established on this continent and the experiences of bilateral full communion relationships in order to bridge this gap.

Both Canadian churches approved it at their national gatherings this summer. The Episcopal Church's calendar puts consideration later.

The way forward for this church is distinctive. At the 2019 Churchwide Assembly, the ELCA approved a constitutional change (bylaw 8.19.02), which provides that the "ecumenical availability of ministers of Word and Sacrament under relations of full communion" shall apply to "churches who have established a full communion relationship with a member church of The Lutheran World Federation provided that church is a member of a Christian World Communion that has a member church that is in full communion with this church" – churches like the ACC, which is linked on the one side to the ELCIC and on the other to TEC. Adopting the Memorandum both applies this provision explicitly to the Anglican Church of Canada and also affirms the supporting ecumenical agreement which all four churches joined in proposing.

The background, rationale and actions that comprise the <u>Memorandum</u> can be found in the November 2019 Church Council materials. The Conference of Bishops received a report on the Memorandum and commended it for Church Council's adoption [CB19.09.20]. Presiding Bishop Eaton will present the report and recommendation.
