Description


The ELCA Endowment Fund Pooled Trust (Fund A, or the Fund), was established to allow for the collective long-term investment of funds belonging to the Evangelical Lutheran Church in America (ELCA), its congregations, synods, seminaries and other eligible affiliated entities. To the extent practicable, the Fund pursues investment objectives in line with the Economic Social Criteria Investment Screens approved by the ELCA Church Council. Incorporated into the Fund's accounting are unitization and quarterly endowment distributions. The ELCA Foundation administers the Fund.

Only ELCA-related institutions can be eligible to participate in this investment fund that is exempt from most security registration requirements in accordance with the Philanthropy Protection Act of 1995.

About Performance


The investment results depicted herein represent historical net performance after the deduction of investment manager and custodian fees and expenses including the administrative fee of 60 basis points (0.60%). Prior to July 2017, the total fee was 100 basis points (1.00%). Annual, cumulative and annualized total returns are calculated assuming reinvestment of dividends and income plus capital appreciation. Performance for periods greater than one year is annualized. Underlying returns were provided by the Fund's respective managers. *Past performance is not a guarantee of future results*.

Target Allocation¹



Growth of \$100 (10 Years Performance Analysis)



Capital Markets Commentary (as of October 31, 2021)

Capital Markets Overview

Markets continued momentum in October thanks in part to encouraging corporate earnings and easing of fears around China's property sector. Economic data indicated a market slowdown in activity, but consumer confidence is very high. Disruptions in the supply chain leading to shortages of big-ticket items seems to have discouraged spending more than a decrease in demand. The economic data did not have an impact on the Federal Reserves plan to taper their purchases in December as they still believe elevated inflation figures are still believed to be transitory.

Domestic Equity Markets


The S&P 500 returned 7.0% in October. All of the S&P 500 sectors showed positive returns across the board. Consumer Discretionary, Energy, and Technology outperformed and returned 10.9%, 10.4%, and 8.2%, respectively. Laggards included Utilities,, Consumer Staples, and Telecom coming in at 4.7%, 3.9%, and 2.8%, respectively.

International Equity Markets

International equities underperformed the U.S. in October. Developed international markets, as measured by the MSCI EAFE index, rose 2.5% for U.S. currency investors. The MSCI Europe index rose 4.5%, Japanese equities retreated -3.4% per the MSCI Japan Index. Emerging market equity markets, as measured by the MSCI Emerging Markets index, posted a 1.0% gain.

Fixed Income Markets

Overall Bond markets were slightly negative to flat during October. The Bloomberg U.S. Aggregate Bond index remained flat over the period The yield on the 10-year Treasury closed at 1.5%, staying flat for the month. Riskier parts of the bond market, had muted gains for the month. The Bloomberg High Yield index fell a modest -0.2% in October.



The <u>Target Benchmark</u> is comprised of: Russell 3000 (25%), MSCI ACWI xUSA IMI (29%), Bloomberg Barclays Capital U.S. Aggregate (8%), Bloomberg Barclays Capital U.S. High Yield Ba/B 1% Issuer Cap (5%), Bloomberg Barclays Capital U.S. 1-10 Yr Inflation Linked (5%), DJ U.S. Select Real Estate Securities (2.4%), DJ Glb xUSA Select Real Estate Securities (1.6%), HFRX Global Hedge Funds (5%), S&P Global Infrastructure (5%), Cambridge Private Equity (10%), and 90 Day T-Bill (4%) indices. The benchmark is rebalanced on a monthly basis.

The Modified Target Benchmark: Given the 10% SAA Target allocation for private markets will fund over the course of five years, the Modified Target benchmark was created to mimic the same risk profile of the SAA Target by re-weighting the underlying target benchmark index weights (as described above) relative to the current allocation to private markets. The Modified Target Benchmark date of first use was January 1, 2021.
