When an elected official hears from constituents, your local experiences and convictions can have impact.

FARM BILL BACKGROUND

The farm bill is omnibus (meaning several different parts all joined together) legislation that is critical to addressing hunger in the United States and globally. It covers federal nutrition programs such as the Supplemental Nutrition Assistance Program (SNAP) and Women, Infants, and Children (WIC), environment, trade, foreign aid and rural development. The bill impacts the lives of Lutherans and our communities – among us are farmers and ranchers and Indigenous communities and global partners and low-income Americans.

To get a better picture of what the Farm Bill entails and how it becomes policy, consider this 5-minute video from the Oklahoma Cooperative Extension Service made in 2019. "What is the Farm Bill?"

Also helpful from the National Sustainable Agriculture Association is a video in 4-minutes that describes how the farm bill "connects the food on our plates, the farmers and ranchers who produce that food, and the natural resources – our soil, air and water – that make growing food possible." WRITING YOUR LETTER

Start by identifying elected officials in your area. Use govtrack.us to find federal officials or openstates.org among other lookup tools. It may be of interest to go to the website of that lawmaker. Spend some time to explore which committees the person serves on or legislative areas the person particularly cares about, and maybe even reference what you find in your letter.

We've provided a very basic template to get you started, but it does not have much information on it - on purpose. What you know about your location and in your experience carries the most weight when reaching out to your elected officials.

- Themes to reflect in your letter could focus on: Hunger & Nutrition (local and global); Environment and Creation Care; Agricultural Connections; among others.
- Your personal story and values, experience of your congregation and ministries such as a food pantry or meal program, and reflections on local community impacts set your letter apart.

Dear Senator [name]:

As a Christian, your constituent and a resident of [town], I am writing to you about the Farm Bill. While Congress works to renew our food and farm programs by reauthorizing the bill, I urge you to support legislation that builds healthy, equitable and sustainable food systems.

My congregation in your district, [name], operates a food pantry that serves over 200 of our neighbors and members every week. But hunger is still a chronic and growing issue in [town], and pantries are barely able to keep up with the demand. Last week I spoke with someone patronizing our pantry who, like many, works but still can't keep up with the growing cost of living. Core issues such as expanding SNAP eligibility in the Farm Bill will do more than our food pantry can do alone, reducing hunger in [town] and many other towns.

Faith communities and their social ministries are working to meet needs, but we cannot address food insecurity and intertwining realities for our agricultural communities on a broad scale. Reauthorization is an opportunity TIPS FOR YOUR LETTER

Use proper form of address

Begin by clearly stating your strongest point or position.

Include a personal story or experience to illustrate why the issue is important to you and how it affects you, your neighbors and your community.

Cite an example of how you and/or your congregation is involved in an issue you care about, or what faith conviction informs your position on a

to advance significant good for all of us, including those who need basic nutritional support to stay healthy. Our agricultural community is vital to our daily lives, and this Farm Bill reauthorization can support farmers' vocations, the ability of tribal nations to advance their food sovereignty and security, and related factors that will impact the health of our communities immediately and in years to come.
